Call for nominations for the IDB Prize in Islamic Economics for 1434H (2013G)

The Islamic Development Bank Group is pleased to invite individuals, universities, academic, financial and Islamic institutions throughout the world to nominate whoever they down eligible to be awarded the IDB Prize for the year 1434H (2013G) in the field of Islamic Reconomics. The Prize which aims to recognize, reward and encourage creative efforts of outstanding ment in the field of Islamic economics, consists of a citation carrying the IDB's emblem and a cash award of 30,000 Islamic Dinars (approximately US\$ 46,000).

The Conditions Required for the Nomination of individuals

- A Nominee should have made an academic or practical contribution of outstanding merit in the field of Islamic Economics.
- Research works, submitted for the Prize, should be published and academically recognized.
- Services of the Nominee should have an effective impact on Islamic Economies and its development.
- The Nominee should not be a Staff Member of IDB Group.
- The Research works, submitted for the Prize, should not have been awarded any International Prize before.
- Self-nomination and the nomination of nonliving researchers are not acceptable.

The Conditions Required for the Nomination of Institutions:

- The Nominated Institution should have made an academic or practical contribution of outstanding ment in the service of Islamic Economics.
- Services of the Nominated Institution should have an effective impact on Islamic Economics and its development.
- The Nominated Institution should be recommended by at least one or more eminent scholars in field of Islamic Economics.
- The Nominsted Institution should not have been awarded the IDB Prize before.
- Nomination of institutions by its Management is not acceptable.

The Requirements for the Nomination:

- 1. The nomination form.
- The Letter of Nomination (in one of the three languages: Arabie, English or French) should motivate the reasons for the nomination.
- 3. The detailed Curriculum Vita for the individual/ A detailed prospectuses for the Institution.
- The research works/publication/services submitted in support of the nomination.
- A detailed report (with executive nummaries) of the research works/publication/services submitted in support of the nomination. The detailed report abould be carefully elaborated since it is very important for the evaluation.
- The above documents should be sent by curail to idbprize@lsdb.org before 1th Muhamm 1434H (15th November 2012).
- Books/research papers/etc. that cannot be sent by cmail should be mailed in hard copies to the below mentioned address and delivered to the Preparatory Committee of the IDB Prize before 16th Muharman 1434H (30th November 2012)
- 8. Any nomination received after the first deadline will not be considered.

Prize Awardbig:

The Winner(s) of the award will be honored at a occurrony at the IDB Group Annual Board of Governors meeting. The IDB Group reserves the right to withhold awarding the Prize.
