Petitioner

The Philippine Association of Flour Millers, Inc. (PAFMI) has filed a petition with the Department of Agriculture (DA) for the imposition of anti-dumping duties on the importation of flour from Turkey. PAFMI claims that these flour imports from Turkey are being sold at a price below fair value on the home market, thereby causing material injury to the domestic flour industry.

WHEREFORE, IN VIEW THEREOF, it is recommended that the Department of Agriculture (DA) be authorized to impose anti-dumping duties on the importation of flour from Turkey.

As a condition for the imposition of anti-dumping duties to the above, bond will be required from the importer to ensure the payment of the duties on the importation of flour from Turkey.
