INDONESIA

(Wheat Flour)

The following communication dated 7 May 2014, is being circulated at the request of the Delegation of Indonesia.

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, the Republic of Indonesia hereby notifies on the imposition of a safeguard measure in the form of quota on the importation of Subject Good, for a period of 7 (seven) months by the issuance of Minister of Trade's Decree Number 23/M-DAG/PER/4/2014 dated 28 April 2014, promulgated in the Berita Negara of The Republic of Indonesia Year 2014 Number 579 on 29 April 2014.

1 BACKGROUND

On 5 June 2013 The Republic of Indonesia notified on the findings of investigation in which it was concluded that there was strong evidence that the increased of volume of imports of the Subject Good have caused serious injury to the domestic industry concerned (Ref. G/SG/N/8/IDN/15-G/SG/N/10/IDN/15).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia the imposition of a safeguard measure on the importation of Subject Good.

2 SUBJECT GOOD

Wheat Flour under HS Code 1101.00.10.

3 DESCRIPTION OF THE SAFEGUARD MEASURE

1. With reference to the proposal from the Investigating Authority, and taking into account the need to effectuate the safeguard measure as proposed and the relevant requirements stipulated in the WTO Agreement on Safeguards, the Government of the Republic of Indonesia has decided to impose safeguard measure in the form of quota as follow:

2. The duration of safeguard measure is from 4 May 2014 to 4 December 2014.

3. In accordance with article 12.3 of the Agreement on Safeguards, the Investigating Authority have provide adequate opportunity for prior consultation with members having a substantial interest on the subject good.

4. The Subject Good originates from developing countries with a market share which does not exceed 3 per cent, provided that developing country Members with less than 3 per cent import share collectively account for not more than 9 per cent of total imports, shall be excluded from the imposition of the safeguard measure.
