Unofficial translation

Dear Sirs!

For the purpose of further cooperation between Krasnodar Region and the Republic of Turkey Kuban business community expressed the interest in:

- studying the demand for hard-wooded broadleaved wood species (lumber of beech wood, oak-tree, ash tree, alder, lime tree) to be exported from Krasnodar Region to Turkey for furniture manufacturers (the list of potential partners – furniture manufacturers is attached);

- joint implementation of an investment project in Krasnodar Region - a full-cycle wood processing cluster for added-value wood conversion, including:

 creation of a specialized transportation and logistics centre of board lumber for timber procurers and wood processing companies of Krasnodar Region

 creation of house building, furniture producing (cabinet furniture, upholstered furniture, kitchen, office and exclusive furniture) enterprises

• creation of enterprises on manufacture of equipment for kitchens and shop fixtures and equipment

- creation of a joint investment and construction company on the basis of a Kuban enterprise, accredited at leading state electronic trading platforms for implementation of such projects, such as reconstruction of the city centre of Krasnodar, construction of economy class residential districts, performance of bank protection and hydraulic construction works, construction of marines and berthing infrastructure, roads by way of participation in tenders, auctions, as well as on terms of public-private partnership;

- attracting of Turkish investment companies in projects on creation of the cluster that includes such facilities as composite fixtures manufacturing enterprises, paint-and-lacquer coating, dry construction mixtures, gypsum cardboards and aeroconcrete for the needs of the construction sector of Krasnodar Region;

- creation of an investment and designing office for coordination and modification of joint investment projects, organization of meetings and negotiations with Turkish companies, which expressed their interest to certain partnership proposals, received from Kuban companies;

- creation of an industrial park that includes an export-import transportation and logistics centre with a class A low temperature terminal, designed for storage of chilled and frozen products, processing, pre-packing and packing of various foodstuffs (vegetables, fruits, fish, meat, spices, tea) in the customs area of Kavkaz or Novorossiysk seaports (Krasnodar Region, the Russian Federation);

- in organization of wholesale supplies of construction materials, furniture, wallpaper and sanitary ware to Krasnodar Region.
