RESOLUTION No. 2188

On Amendments to the rates of export customs duties on goods exported from the Russian Federation outside the customs Territory of the Eurasian Economic Union

The Government of the Russian Federation decides:

1. Approve the attached amendments to the rates of export customs duties on goods exported from the Russian Federation outside the customs territory of the Eurasian Economic Union, approved by the Decree of the Government of the Russian Federation dated November 27, 2021 No. 2068 "On the rates of export customs duties on goods exported from the Russian Federation outside the Customs Territory of the Eurasian Economic Union" (Collection of Legislation of the Russian Federation, 2021, No. 49, Article 8255; 2022, No. 14, Article 2306; No. 23, Article 3800; No. 27, Article 4864; No. 32, Article 5834; No. 37, Article 6371).
2. This Resolution comes into force on January 1, 2023

Changes

which are included in the rates of export customs duties on goods exported from
the Russian Federation outside the customs territory of the Eurasian Economic Union

1. After the position classified by the custom code 2711 21 000 0 add the following items:

"3102	mineral fertilizers or chemical, nitrogen	0 (19C),(20c)
3103	mineral fertilizers or chemical, phosphoric	0 (19C),(20c)
3104	mineral fertilizers or chemical, potash	0 (19C),(20c)
3105	mineral fertilizers or chemical containing two or three nutrients: nitrogen, phosphorus and potassium; other fertilizers; products of this group in tablets or similar forms or in packages whose gross weight does not exceed 10 kg	0 (19C),(20c)

2. Add footnotes (19C) and (20C) as follows:

"(19C) If the customs value per 1000 kg of mineral or chemical fertilizers, nitrogen, phosphorus, potassium, as well as containing two or three nutrients: nitrogen, phosphorus and potassium, other fertilizers, goods of Group 3105 of the Customs Code of the EAEU when they are exported from the Russian Federation outside the customs territory of the Eurasian Economic Union does not exceed the amount equivalent to 450 US dollars inclusive. If the specified level of customs value is exceeded, the export customs duty rate is applied in the amount of 23.5 percent of the difference between the customs value and 450 US dollars.

(20C) For this item, the rate of export customs duty is applied until December 31, 2023 inclusive.".

Утвердить прилагаемые изменения, которые вносятся в ставки вывозных таможенных пошлин на товары, вывозимые из Российской Федерации за пределы таможенной территории Евразийского экономического союза, утвержденные постановлением Правительства Российской Федерации от 27 ноября 2021 г. № 2068 "О ставках вывозных таможенных пошлин на товары, вывозимые из Российской Федерации за пределы таможенной территории Евразийского экономического союза" (Собрание законодательства Российской Федерации, 2021, № 49, ст. 8255; 2022, № 14, ст. 2306; № 23, ст. 3800; № 27, ст. 4864; № 32, ст. 5834; № 37, ст. 6371).

2. Настоящее постановление вступает в силу с 1 января 2023 г.
